

LEGAL BASIS OF THE SWEEPSTAKES

"MAKING A TEAM TO CHANGE LIVES"

1.- ORGANIZING COMPANY AND OBJECT

Asociación de Amigos de los Animales Abandonados Triple A (hereinafter, Triple A), with registered office carretera A-355 kilómetro 5, postal code 29610 and with CIF G-29598059, will carry out a draw for 5 official shirts signed by players of Unicaja Malaga, , Málaga Club de Fútbol, Rincón Fertilidad Málaga, Club Baloncesto Marbella y Marbella Fútbol Club (hereinafter, the "Draw").

2.- OPERATION AND DRAW PERIOD

Users who (a) make a donation of 10 euros to the account number ES20-0081-7460-6300-0101-0211 between the period established with "DRAW + Telephone number" as concept will enter into the Sweepstakes.

The Draw will take place between Thursday, May 20, 2021 and Saturday, May 29, 2021 at 11:59 p.m. The result of the draw will take place on Sunday, May 30 at 8:00 p.m.

3.- TERRITORIAL SCOPE

The territorial scope of this draw will be Spain (except the Balearic Islands, the Canary Islands, Ceuta and Melilla).

4.- LEGITIMATION TO PARTICIPATE

Those people who make a donation of 10 euros to the indicated account with the indicated concept, with legal residence and domicile in national territory (except Balearic Islands, Canary Islands, Ceuta and Melilla) may participate in the Draw.

5.- PROMOTION MECHANICS

As previously indicated, all users who:

- Make a donation of 10 euros (or more) in the account ES20-0081-7460-6300-0101-0211 with the concept "DRAW + Telephone number"

The user can participate as many times as he wants through different donations (always with a minimum of 10 euros). Or with a transfer (donation) always in multiple amounts of 10 €, for example 30 € is equivalent to 3 participations.

The same user cannot win more than once, unless the user has participated as before stated in previous paragraph.

Winners will be chosen through a random winner selection platform.

Each winner will get 1 signed shirt.

The total of winners will be 5 users.

The award winners will be communicated through TRIPLE A's Instagram and Facebook on May 30, 2021 at 8:00 p.m.

The prize will be awarded only to the user who has participated in the raffle and who has been chosen as the winner and who meets the requirements described in these rules. The prizes are personal and non-transferable.

6.- DELIVERY OF THE PRIZES

In order to accept and obtain the prize, the winner will have to contact the TRIPLE A account by direct message through Instagram or Facebook within a maximum period of 48 hours after the name of the winner is announced.

Participants are responsible for the contact information they provide, as well as for reviewing the messages sent to their Instagram or facebook accounts.

In the event that the winner does not accept the prize in accordance with the established conditions, the reception of private or public messages are restricted and if they do not contact the TRIPLE A profile to send the requested data within the indicated period or do not meet the requirements described in these rules, it will be understood that they reject to do so and the prize will be passed to the substitute with whom the same procedure as with the winner will be followed. 8.- PERSONAL DATA

The data of the winners will be processed in accordance with the provisions of the Organic Law on Protection of Personal Data (LOPD 3/2018, of December 5) and EU Regulation 2016/679.

The Data Controller is TRIPLE A, who may process the data in order to manage the delivery of the prizes that are the object of the promotion and / or for the purposes of advertising and commercial prospecting.

In accordance with EU Regulation 2016/679, participants may exercise their rights of access, rectification, deletion, limitation, opposition and portability of their data by email addressed to admin@tripleamarbella.org

The indication of the personal data of the winners will be mandatory for the management of the prize. Any false communication of personal data will entitle the organizers of the promotional actions to disqualify the winner from participating and be able to dispose of the corresponding prize.

9.- UNLINKING FROM INSTAGRAM AND FACEBOOK

The platform does not sponsor, endorse, or administer this Sweepstakes in any way, nor is it associated with it. The user is aware that he is providing his information to TRIPLE A.
